

FUNNY-ISH FAMILY IN AMERICA CONTEST

NO PURCHASE OR PAYMENT NECESSARY. A PURCHASE WILL NOT ENHANCE YOUR CHANCES OF WINNING.

- 1. Eligibility:** The Funny-ish Family In America Contest ("Contest") is only open to entrants who, at the time of entry, are: (a) natural persons who are legal residents of one of the 50 United States or the District of Columbia, (b) 18 years of age (or, if different, the age of majority in such entrant's jurisdiction of residence) or older, and (c) have either (i) a Twitter account and/or (ii) an Instagram account. Potential winner and non-minor guests must submit to background checks and must not be convicted of, or currently charged with, a felony or a crime of moral turpitude, as determined by Sponsor in its sole discretion. Entrants must not be an employee or director, or IRS dependent, immediate family member or individual residing in the same household of, an employee or director of Buena Vista Home Entertainment, Inc. ("Sponsor"), Prize Logic, LLC ("Administrator"), or their respective parents, subsidiary and affiliated companies, advertising, promotion, or production agencies, web masters, web suppliers and any prize providers. Void where prohibited by law and subject to all applicable federal, state, and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these official rules ("Official Rules") and Sponsor's and Administrator's decisions, which are final and binding in all matters related to the Contest. Winning is contingent upon fulfilling all requirements set forth herein.

- 4. Timing:** Contest begins at 12:00:00 PM (noon) Pacific Time ("PT") on October 22, 2018 and ends at 11:59:59 PM PT on November 26, 2018 ("Entry Period"). Immediately following the Entry Period, a "Judging Period" will commence to determine the 1 Contest Winner, as further described in Section 8 of these Official Rules. The Entry Period and Judging Period together are the "Contest Period". Administrator's computer is the Contest's official clock.
- 5. How to Enter:** During the Entry Period, an eligible entrant must log onto their Twitter or Instagram account and post an original photograph or video (not to exceed 30 seconds) showing how their family is the "funny-ish family in America" along with the hashtag #FunnyishFamilyContest (each, an "Entry" and collectively, "Entries"). For purposes of this Contest, "family" is defined as individuals who are related by blood, law, and/or domestic partnership. NOTE: Entries must not include any music to be considered eligible for entry into the Contest. After posting an Entry with the required hashtag, an entrant will receive 1 entry into the Contest.

If an entrant participates on Twitter, they must have a Twitter account. Entrants may create a Twitter account at no cost by logging on to <http://twitter.com>. Creation of a Twitter account requires Entrant to agree to Twitter's Terms of Service and Privacy Policy, available at: <https://twitter.com/tos/> and <https://twitter.com/privacy>, respectively. Due to the way Twitter operates its services, all relevant Tweets must be public in order for entrant to be considered eligible for entry into the Contest.

If an entrant participates on Instagram, they must have an Instagram account. Entrants may create an Instagram account at no cost by logging on to <http://instagram.com>. Creation of an

Instagram account requires entrant to agree to Instagram's Terms of Service and Privacy Policy, available at <http://instagram.com/about/legal/terms/> and <http://instagram.com/about/legal/privacy/>, respectively. Due to the way Instagram operates its services, Entries from Instagram users with "protected" accounts (i.e., entrant has set their account so that only people the entrant has approved can view their updates) may not be received and may not be considered eligible for entry into the Contest.

By participating, each entrant agrees that their Entry complies with these Official Rules, including the Entry Guidelines and Requirements set forth in Section 7 of these Official Rules.

By participating, each entrant warrants and represents the following with respect to their Entry: (a) the Entry will not infringe on any rights of any third parties; and (b) that entrant has not and will not take any action that interferes with the rights granted to Sponsor under these Official Rules.

NOTE: If an entrant enters the Contest from a mobile device, the entrant's wireless service provider may charge the entrant for applicable data charges. Entrants should consult their wireless service provider regarding its pricing plans. Message and data rates may apply. Entrants should review their mobile device's capabilities for specific app instructions.

By participating and using the required hashtag, entrant hereby agrees to the terms and conditions set forth in these Official Rules and The Walt Disney Company Terms of Use, available at <https://disneytermsofuse.com/>.

There is a limit of 1 Entry via each method listed above for a total of 2 Entries during the entire Entry Period. If entrant enters more than 1 time per method of entry, only the first Entry received may, at Sponsor's sole discretion, be considered valid. An entrant may submit multiple Entries using each of the methods of entry, but each Entry must be unique and different from the other Entry used by an entrant to enter the Contest. An entrant may use only 1 Twitter account and/or Instagram account to enter. Entrants attempting to use multiple Twitter accounts, multiple Instagram accounts, or multiple identities may be disqualified, at Sponsor's sole discretion.

- 6. Grant of Rights by Entrant:** Each entrant hereby grants to Sponsor a non-exclusive, sublicensable, irrevocable and royalty-free worldwide license under all copyrights, trademarks, patents, trade secrets, privacy and publicity rights and other intellectual property rights to use, reproduce, transmit, print, publish, publicly display, exhibit, distribute, redistribute, copy, index, comment on, modify, adapt, translate, create derivative works based upon, publicly perform, make available and otherwise exploit such entrant's Entry(ies), in whole or in part, in all media formats and channels now known or hereafter devised (including, without limitation, on third-party sites and platforms such as Facebook, YouTube, Instagram and Twitter), in any number of copies and without limit as to time, manner and frequency of use, without further notice to entrant, with or without attribution, and without the requirement of permission from or payment to entrant or any other person or entity. Entries may be displayed on FunnyishFamilyContest.com, BlackishTV.com, and @blackishTV Instagram, Facebook and Twitter social media accounts and that any such display by Sponsor or Administrator will have no effect on judging and is for entertainment purposes only.

Additionally each entrant consents to the use of the names, account names, social handle names, statements, photographs, videos, voice recordings and likenesses of themselves and

any other person appearing in the Entry(ies) for publicity purposes, as well as any other purpose associated with the Contest.

If requested, entrant will sign any documentation that may be required for Sponsor or its designees to make use of the non-exclusive rights entrant is granting herein in connection with their Entry(ies).

7. Entry Guidelines and Requirements: Each Entry:

- A.** Must comply with Twitter's or Instagram's posting requirements depending upon the platform on which the Entry is posted;
- B.** Must not exceed 30 seconds, if Entry is a video;
- C.** Must be the original work of the entrant (not copied, adapted, or reproduced from any other source and not a collaboration with any other person) and must not contain material that violates or infringes another's rights, including but not limited to privacy, publicity or intellectual property rights, including copyright infringement, or legal or moral rights of any third party, living or deceased (e.g., music, names, logos, symbols, slogans, submissions that belong to others, Entries of other people, quotes from other people, or parodies of other people);
- D.** Must not have been submitted previously in a promotion of any kind;
- E.** Must have approval from any persons appearing in the Entry and the entrant must be able to provide express written consent of every such person appearing in the Entry to Sponsor and/or Administrator if requested. If any such person is a minor the entrant must be their parent/legal guardian;
- F.** Must not disparage Sponsor, Administrator, or any other person or party affiliated with the promotion and administration of this Contest;
- G.** Must not include personally identifiable information in the Entry;
- H.** Must not include any music, including without limitation, any background music;
- I.** Sponsor discourages use of any logos, brand names or trademarks. Use of logos, brand names or trademarks may be permitted provided such brand names or logos are not prominently featured. Sponsor reserves the right to disqualify the Entry, if Sponsor believes, in its sole and absolute discretion, that there is any inappropriate use of a logo, brand name, or trademark;
- J.** Must comply with all other Entry Guidelines and Requirements described in this Section 7 and all other provisions of these Official Rules;
- K.** Must not contain, facilitate, reference, or use material that is dangerous, fraudulent, inappropriate, indecent, lewd, pornographic, obscene, hateful, tortious, defamatory, slanderous or libelous;
- L.** Must not contain, facilitate, reference or use material that contains prohibited content which shall include, but is not limited to content that promotes, suggests, or encourages:
 - i.** any cruelty to, or mistreatment in any way of animals;
 - ii.** gambling, including without limitation, any content related to online casinos, sports books, bingo or poker;
 - iii.** the use of firearms/weapons/ammunition, any illegal drugs, prostitution, pornography, nudity, profanity or other adult content, violence, or the use of alcohol or tobacco products;
 - iv.** the taking up of arms against any person, government or entity or otherwise challenge or seek to overthrow any government;
- M.** Must not contain any viruses, spyware, malware, or other malicious components that are designed to harm the functionality of a computer in any way;

- N. Must not contain, facilitate, reference, or use material that promotes bigotry, racism, hatred or harm against any group or individual or promotes discrimination based on race, gender, ethnicity, religion, nationality, disability, sexual orientation, political orientation, citizenship, ancestry, marital status, or age; and
- O. Must not contain material that is unlawful, in violation of or contrary to the laws or regulations in any jurisdiction where Entry is created or otherwise promotes any unlawful, illegal, unsafe, dangerous or reckless behavior.

NOTE: If any Entry fails to comply with any of these Entry Guidelines and Requirements or any other provisions of these Official Rules, Sponsor reserves the right, in its sole discretion, to disqualify the entrant.

- 8. Judging Period and Winner Selection:** Eligible Entries will be judged by a panel of qualified judges selected by Administrator (the “Judges”). The Judges will score the Entries according to the following weighted factors: (a) Humor (34%); (b) Creativity (33%); and (c) Originality (33%). The Entry that receives the highest score from the Judges will be deemed the potential “Winner”, pending verification of eligibility and compliance with these Official Rules. In the event of any ties, the highest score in criterion 1, Humor, will be used to break any ties. In the event there is still a tie after the first tie breaker, then the highest score in criterion 2, Creativity, will be used to break the tie. In the event there is still a tie after the second tie breaker, then the tied Entries will be re-judged by an independent judge to determine the 1 Winner. In no event will there be more than 1 Winner.

Sponsor’s and Administrator’s decisions as to the administration and operation of the Contest and the selection of the potential Winner are final and binding in all matters related to the Contest.

The potential Winner will be notified at their Twitter or Instagram account via a direct message from @blackishTV with instructions on how to claim the prize. The potential Winner must respond to the email address provided in the initial direct message within 72 hours with their e-mail address or the prize may (in Sponsor’s sole discretion) be forfeited. The potential Winner will then be notified at the provided e-mail address by the Administrator. The potential Winner must respond to the initial notification from Administrator within 72 hours of such notification or the prize may (in Sponsor’s sole discretion) be forfeited.

Acceptance of the prize shall constitute and signify the Winner’s agreement and consent that Sponsor and its designees may use the Winner’s name, city, state, likeness, photograph, video and/or prize information in connection with the Contest for promotional, advertising or other purposes, worldwide, in any and all media now known or hereafter devised, including without limitation, the Internet and without further payment, notification, permission or other consideration, except where prohibited by law.

The potential Winner will be required to execute an Affidavit of Eligibility, a Liability Release, and (where imposing such condition is legal) a Publicity Release (collectively, “Prize Claim Documents”) within 10 calendar days from the date such Prize Claim Documents are sent to the potential Winner. The Winner’s guests will also be required to sign and return a liability and/or publicity release(s) and other paperwork at the same time the potential Winner returns their affidavit of eligibility, liability release, publicity release and other paperwork. Additionally, the potential Winner and each of their guests aged 18 or over may be subject to a background check before the prize is awarded. Sponsor reserves the right, in its sole discretion, to disqualify the potential winner and/or any guest if the results of such background check reveal

that the potential winner and/or any guest is not eligible to participate in the Contest or has been convicted/charged with a felony or crime of moral turpitude, as determined by Sponsor in its sole discretion.

At the sole discretion of Sponsor, disqualification, forfeiture and the selection of an alternate Winner may result from any of the following: (a) potential Winner's failure to respond to Sponsor's instructions per the initial direct message notification within 72 hours; (b) potential Winner's failure to respond to Administrator's initial notification within 72 hours; (c) the return of a notification as undeliverable; (d) potential Winner's failure to provide Administrator/Sponsor with satisfactory proof of age, identity and residency; (e) any non-compliance with these Official Rules; and (f) failure to execute and return the required Prize Claim Documents within 10 calendar days from the date such documents are sent to the potential Winner.

In the event that the potential Winner is disqualified for any reason, Sponsor will award the applicable prize to the entrant who submitted the Entry with the next-highest Judges scores. The prize must be claimed by an eligible Winner by December 31, 2018, after which the prize, if not accepted by an eligible Winner, will not be awarded.

9. Prize and Approximate Retail Value ("ARV"):

1 PRIZE: The prize Winner will receive a 4-day/3-night vacation package for Winner and up to 5 guests (together, with Winner, the "Group") to Hollywood, California ("Trip"), an opportunity to attend a meet and greet with select *Black-ish* talent (subject to availability), a VIP tour of The Walt Disney Studios Lot, and a Hollywood movie experience at the El Capitan Theatre. Trip includes:

- Up to 6 round trip coach air fares between the major gateway airport closest to Winner's residence ("Airport of Origin") and a Southern California airport as chosen by Administrator (with possible layovers); provided, however, if the Winner resides within 250 miles of Hollywood, California, air fare will not be provided to the Group.
- A voucher for up to 6 round trip ground transfers between the Southern California airport and the hotel as chosen by Administrator; provided, however, if the Winner resides within 250 miles of the hotel, such ground transfers will not be provided to the Group.
- Room accommodations for the Group, consisting of up to 2 standard rooms (with a maximum of 4 persons per room) for 3 consecutive nights at a hotel at the hotel as chosen by Administrator; daily parking at the hotel is not included.
- 1 Hollywood movie experience at the El Capitan Theatre for the Group, consisting of up to 6 VIP movie tickets for the current attraction playing at the El Capitan Theatre.
- 1 gift card with a value of \$1,000 for the Winner only. Subject to restrictions imposed by the issuer of the gift card.

The ARV of the prize is \$9,244. The prize is awarded entirely to the winner entrant and not the Winner's family. The winning entrant will have the sole right to decide which individuals will accompany him or her on the Trip as their guests.

Additional Terms and Conditions: Prize may not be declined once awarded to and accepted by Winner. Prize may not be bartered, transferred, sold, separated, substituted, or redeemed for cash value in whole or in part. Sponsor, in its sole discretion, reserves the right to substitute a listed prize or prize component for one of equal or greater value if the designated prize or

component should become unavailable for any reason or unreasonably difficult to fulfill. Winner must pay all applicable taxes and fees for prizes accepted.

Travel must be booked at least 45 days prior to travel date. **Trip to Hollywood must be taken by March 1, 2019** or else the winner will forfeit the prize in its entirety and the prize will be awarded to an alternate winner (time permitting). If travel is not timely booked or completed within the required dates, prize will be forfeited and Sponsor and Administrator will have no further obligation to such Winner. Travel dates to be mutually agreed upon by Winner and Sponsor subject to the *Black-ish* production schedule and the cast's availability and professional commitments; however, Sponsor shall have final approval over the travel dates in its sole discretion. The attendance by any specific cast member or any other talent from *Black-ish* is not guaranteed and shall be subject to availability and Sponsor's sole discretion. If Winner is unable to travel once the travel dates are booked, the prize will be forfeited in its entirety. In the event Winner is able to travel on the scheduled travel dates, but the cast meeting does not or cannot take place as scheduled or at all, for reasons including but not limited to postponement, location changes, an event of force majeure, or for any other reason, then Administrator/Sponsor reserves the right to award the remainder of the prize with no further obligation to the Winner. Winner and his/her guests will meet members of the cast in one session at a time and location to be determined by Sponsor in its sole discretion, with Sponsor's representative(s) and other individuals also being present at all times. Winner and guests must follow all instructions of Sponsor relative to the cast meeting and, should Winner and/or guests fail to adhere to such instructions or engage in unruly, obnoxious, anti-social or otherwise inappropriate behavior (as determined by Sponsor in its sole discretion), Sponsor reserves the right, without further notice or warning, to terminate the Trip and/or remove Winner and/or guests from the set and/or take other actions as Sponsor deems appropriate in its sole discretion so as to protect its rights, without liability or other obligation to Winner and/or guests. The cast meet and greet has no monetary value.

Each traveler must be at least 18 years of age, unless such traveler is accompanied on the Trip, as a member of the Group, by their custodial parent or legal guardian 18 years of age or older. Winner may not charge their guests for participating in the Trip.

All prize-related travel arrangements will be administered by Administrator or Administrator's authorized designee. Travel is subject to capacity controls, availability, weather, seasonal influences, and certain other restrictions, all of which are subject to change. Winner and their guests will be required to travel on the same itinerary including the same departure date and return date. Air transportation and hotel accommodations must be taken together and cannot be taken separately. Guests must stay in the same hotel room as Winner. No changes will be made to travel details once any element(s) of the travel arrangements have been booked, except at Administrator's sole discretion. All airline tickets issued in conjunction with the prize are not eligible for upgrades, frequent flyer miles or any other promotional benefit and are nonrefundable and nontransferable. Administrator is not obligated to replace any lost or stolen tickets (including any movie tickets), travel vouchers or certificates or similar items once they are in the Winner's possession or in the possession of a guest. Travel must be roundtrip and to/from the same origin/destination airports. Administrator will determine the flight itinerary in its sole discretion. Once hotel and flight arrangements have been confirmed, no changes will be allowed except at Administrator's sole discretion. No refund or compensation will be made in the event of the cancellation or delay of any flight. Air travel is subject to the terms and conditions set forth in these Official Rules and those set forth by the Administrator's air travel prize supplier, as detailed in the passenger ticket contract issued by such supplier. If the Winner elects to travel or partake in the prize with fewer guests than allowed for, or no guests,

the prize will be awarded in increments suitable for the actual number of participants and no additional compensation will be awarded to the Winner. Any portion of the prize not accepted by Winner will be forfeited.

Except as provided in the description of the Trip above, all federal, state, and local taxes are solely the Winner's responsibility. Winner may receive an IRS Form 1099 reflecting the actual value of the prize. The Winner and their guests are solely responsible for obtaining any desired or necessary travel documents (including government-issued photo identification). The Winner and guests hereby acknowledge that neither Sponsor, nor Administrator has, or will not obtain or provide travel insurance or any other form of insurance for any part of the prize. It is the responsibility of the Winner and their guests to arrive at the designated gateway airport in time for each flight that is part of the prize.

All costs and expenses not specifically stated in these Official Rules as included in the Trip are solely the Winner's responsibility, including, but not limited to: round-trip transportation to and from the Winner's residence, all in-room charges (e.g., mini-bar, movies), excess luggage fees, insurance, custom and immigration fees, passport costs, telephone calls, unspecified meals, alcoholic beverages, upgrades, room service, personal incidentals, amenities, parking, souvenirs, taxes not expressly included in Trip, laundry service, spa services and other optional activities. The Winner will be required to provide a major credit card upon hotel check-in or prior thereto and all in-room charges will be charged to the credit card. Any damage to the room attributed to the Winner and/or their guests will be the responsibility of the Winner.

Sponsor and Administrator bear no responsibility if any event, element or detail of the prize is canceled, postponed or becomes unavailable for any reason. Should any event, element or detail of the prize become unavailable, Sponsor and Administrator have no obligation to the Winner aside from providing the travel portion of the prize, minus any unavailable event, element or detail. The prize Winner and his/her guests shall be subject to all terms and conditions printed on any ticket or voucher issued in conjunction with the prize. In the event the Winner and/or guest(s) is denied entry into any ticketed location or is removed or barred from any ticketed location for any other reason, Sponsor and Administrator are not responsible and no further compensation or award will be provided. **WITHOUT LIMITING THE GENERALITY OF THE FOREGOING, SUCH PRIZES ARE PROVIDED "AS IS" WITHOUT WARRANTY OF ANY KIND, EITHER EXPRESS OR IMPLIED, AND SPONSOR AND ADMINISTRATOR HEREBY DISCLAIM ALL SUCH WARRANTIES, INCLUDING BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE AND/OR NON-INFRINGEMENT.**

Should any member of the Group engage in unruly, obnoxious, illegal, unsafe, threatening or otherwise inappropriate behavior while participating in the prize (as determined by Sponsor or Administrator in their sole discretion), Sponsor or Administrator reserve the right, without further notice or warning, to terminate the applicable activities early, in whole or in part, and send the Group home and/or take other actions as Sponsor or Administrator deems appropriate in its sole discretion without any liability or other obligation to the Group. The Group must comply with the rules and regulations of Administrator and Administrator's authorized designee at all times. Failure to do so may result in forfeiture of the prize.

Prize, or elements thereof, may not be used in conjunction with any other promotion or offer. In the event there is a discrepancy or inconsistency between disclosures or other statements

contained in any Contest promotional materials and the terms and conditions of these Official Rules, these Official Rules shall prevail and govern.

10. Limitations on Liability: By entering, entrants agree that Sponsor, Administrator, Instagram, Twitter, and their respective parents, subsidiaries and affiliated companies, advertising and promotion agencies, and all of their respective officers, directors, employees, representatives and agents (collectively "Released Parties") will have no liability whatsoever, and shall be released and held harmless by entrants, for any injuries, claims, losses or damages of any kind to persons, including death, or property resulting in whole or in part, directly or indirectly, from acceptance, possession, misuse or use of any prize or participation in this Contest or participation in any Contest-related activity, or entrant's failure to comply with these Official Rules. The Released Parties shall not be liable to any Winner or any other person for failure to supply any prize(s) or any part thereof, by reason of any acts of God, any action(s), regulation(s), order(s) or request(s) by any governmental or quasi-governmental entity (whether or not the action(s), regulation(s), order(s) or request(s) prove(s) to be invalid), equipment failure, terrorist acts, earthquake, war, fire, flood, explosion, unusually severe weather, hurricane, embargo, labor dispute or strike (whether legal or illegal), labor or material shortage, transportation interruption of any kind, work slow-down, civil disturbance, insurrection, riot, or any other cause beyond the Released Parties' control. The Released Parties are not responsible for illegible, lost, late, damaged, incomplete, misdirected, or stolen entries; or for typographical or other errors in the offer or administration of this Contest, including but not limited to: errors in advertising, Official Rules, selection and announcement of the Winners and distribution of prizes; or for lost, interrupted or unavailable network, server, satellite, Internet Service Provider (ISP), website or other connections, availability or accessibility; or for miscommunications, failed computer, telephone or cable transmissions, lines, or technical failure; or jumbled, corrupted, scrambled, delayed, or misdirected transmissions, computer hardware or software malfunctions, failures or difficulties; or for any other errors of any kind whether human, mechanical, electronic, technical or network; or for the incorrect or inaccurate capture of entry or other information or the failure to capture any such information; or for any misdirection or delay of any e-mail to be received on account of technical problems or traffic congestion on the Internet, including any injury or damage to entrant's or any other person's computer related to or resulting from participation in or downloading or uploading any materials in connection with the Contest; or for any incorrect or inaccurate information, whether caused by site users, tampering, hacking, or by any equipment or programming associated with or utilized in the Contest; or for any personal injury, death, or damage to or loss of property, arising out of receipt or use or misuse of any prize produced and/or manufactured by a prize provider or other third party.

11. General Conditions: Persons who tamper with or abuse any aspect of the Contest as solely determined by Sponsor, will be disqualified, and Sponsor reserves the right to terminate such entrant's eligibility. Sponsor may also disqualify any person that acts in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person or for any other good cause reason solely determined by Sponsor. Should any portion of the Contest be, in Sponsor's sole opinion, compromised by virus, worms, bugs, non-authorized human intervention or other causes which, in the sole opinion of Sponsor, corrupt or impair the administration, security, fairness or proper play, or submission of entries, Sponsor reserves the right at its sole discretion to suspend, modify or terminate the Contest, and select Winner from Entries received prior to action taken or as otherwise deemed fair and appropriate by Sponsor. In the event of a dispute regarding prize claims or Entries received from multiple users claiming to have the same social media account, the authorized account subscriber of the e-mail address associated with the social media account used to enter will be deemed to

be the entrant and must comply with these Official Rules. Authorized account subscriber is the natural person who is assigned the e-mail address by the Internet Service Provider (ISP), on-line service provider, or other organization responsible for assigning e-mail addresses.
